December 2, 2024

Council President Mary Leatherman opened the meeting with the following members present: Jim Kozumplik, F. John Betts, Richard Hupe, and Stephen Alspaugh. Mr. Kozumplik moved, Mr. Alspaugh seconded, to approve the minutes of the November 18, 2024 Regular Meeting, as written. Roll call vote: all ayes; nays, none. Motion carried.

Bryan resident Steve Cox addressed Council with a brief update on Huntington Drive and to again request recently passed pay data on the Council and Mayor. Figures were provided and Clerk-Treasurer Lehner indicated he would send copies of the two pay ordinances to Mr. Cox.

Ordinance No. 48, 2024, titled,

was presented and read by title only. Mayor Schlade offered support for reappointing City Attorney Marc Fishel for 2025, noting all the work he has done for the City in 2024. Further discussion was held.

was presented and read by title only. City Engineer Wieland explained this project came in \$3,903.30 below budget, and requested approval of the change order.

Mayor Schlade presented a letter of support for Frontier Community Services' development of the Fountain Creek Senior Villas housing project, for which the Williams County Port Authority and Frontier Community Services will seek Ohio Housing Finance Agency funding. This will be the third attempt at securing the annual grant which is awarded by competitive scoring. The project has scored well in the past, but just below the threshold to receive funding.

Mr. Betts moved, Mr. Hupe seconded, to approve and sign a letter of support for the Fountain Creek Senior Villas housing project. Roll call vote: all ayes; nays, none. Motion carried.

Mayor Schlade asked Council to consider a liquor permit transfer between owners of the Get-N-Go Mart and the store's location relative to Lincoln Park. The location of the store has been the same for years and is not changing.

Mr. Hupe moved, Mr. Alspaugh seconded, to waive hearings on the transfer of a liquor permit from Lotto Masters LLC, dba Get N Go Mart to JDS Party Shop LLC and on its proximity to Lincoln Park. Roll call vote: all ayes; nays, none. Motion carried.

Mayor Schlade thanked all involved in preparation for the Santa Parade and Christkindl Market.

Mr. Alspaugh moved, Mr. Kozumplik seconded, to adjourn the meeting. Roll call vote: all ayes; nays, none. Motion carried.
